### Industrial Visit Report

On 3<sup>rd</sup> September 2022, Saturday with a total of 50 students belonging to II B. Com, IV Semester, along with Faculty Co-ordinator Ms Deepika Vettikuntla, Assistant Professor of Commerce, an Industrial Visit was organised for:

- 1) Understanding the costing methods
- 2) For learning process costing
- 3) Determination of cost per unit
- 4) Cost control measures
- 5) Identifying cost centers

The industrial visit started at afternoon 12:00 PM, The Factory Head, Mr. Sanath Kumar P, welcomed everyone to the **UNIBIC** cookies factory. After initial checks at the front gate, the students were taken inside to show the raw materials used to manufacture the cookies, the mixing area, oven area, cocoa room, cookie formation and the packaging section.

Students watched the manufacturing process of two kinds of cookies – chocolate and butter cookies followed by a walk around the packing section. He introduced the company and also mentioned that the company was started in 2004 which is an Australian-originated company. Then he further explained the production levels of the Company where different varieties of cookies are produced.

After the introduction, we were taken to the production site and explained how the manufacturing process takes place. Different segments and layouts were briefly explained to the students. There were three types of packaging namely primary – which has direct contact with the cookies and protects them, secondary – which protects the primary package, tertiary which protects both.

Assembling, Quality checking, warehousing, loading and unloading of the raw materials, and packaging were some of the major functions to which the students were exposed

Mr Sanath Kumar spent 25 minutes clarifying doubts and addressing students' questions.

The students were taken to the factory outlet at the entrance of the UNBIC factory premises. The students arrived back to the campus at 4:00 PM.

## INDUSTRIAL VISIT

### Report on Industrial Visit, Hindustan Coca-Cola Beverages Ltd.

On 11<sup>th</sup> April 2023, Students from Universal School of Administration visited Hindustan Coca-Cola Beverages Ltd located at 18, Bidadi Industrial area, Hobli Ramnagar, Bidadi, Karnataka 562109 with faculty Co-ordinator Ms. Deepika Vettikuntla, Assistant Professor, Department of Commerce.

#### The objectives of the visit were to:

1. To orient the students on company history, organisation structure and its journey so far.
2. To observe the stages in the manufacturing process including procurement of raw materials, bottling and packaging.

The plant layout is a bottling unit that manufactures plastic bottles and tetra packages for beverages. The entire layout of the factory was categorized as per the product portfolio. Carbonated drinks, fruit-based beverages and packaged drinking water are the prime categories. The plant manufactures and packages a variety of carbonated drinks like Coca-Cola, Sprite, Limca etc. and fruit-based drinks like minute maid, maaza etc. The plant also has a separate warehouse for effective inventory management. All the raw materials are unloaded and stored with efficient quality checks.
